## **New Paid Family and Domestic Violence Leave**



Commencing in 2023 employees will be able to access 10 days of paid family and domestic violence leave in 1 12 month period. This includes casual and part time employees.

For small businesses (employers with less than 15 employees on 1 February 2023 this entitlement will be available from 1 August 2023.

For non-small businesses (employers with 15 or more employees on 1 February 2023 the entitlement will commence on 1 February 2023.

### Important notes

Full time, part time and casual employees will be able to access 10 days of paid family and domestic violence leave in 1 12 month period. It will not be prorated for part-time or casual employees.

Employees will continue to be entitled to 5 days of unpaid family and domestic leave until they can access the new paid entitlement.

The entitlement is available up front – there is no accrual. If the entitlement is unused during the year it resets so that at any time a maximum of 10 days leave is available.

Employees accessing paid family and domestic violence leave must be paid at the rate they would have been paid if they had otherwise been at work. Penalty rates for weekend work and casual loadings for instance must be applied. Casuals and part-time employees will be paid for the hours they were expected to work during the period of their absence. For example a casual worker rostered to work 20 hours during a 5 day period that the employee needs leave will be paid for 20 hours including any penalties and casual loadings.
