Phone support

Customer Care Support Plan Rates

Business Software – rates vary depending on your number of users:

Level 1	Single user	- \$90 per month +GST
Level 2	Up to 10 Users	- \$150 per month +GST
Level 3	Up to 20 Users	- \$195 per month +GST
Level 4	Greater than 20 users	- \$240 per month +GST
Level 5	Greater than 40 users	- \$300 per month +GST

Technology – rates vary depending on your number of workstations:

Level 1	Single Workstation	- \$60 per month +GST
Level 2	Up to 20 Workstations	- \$85 per month +GST
Level 3	Up to 40 Workstations	- \$105 per month +GST
Level 4	Greater than 40 Workstations	- \$190 per month +GST

Please note:

- Multiple Site clients will be charged on the total number of Users or PC's

Should you wish to take up both Business Software and Technology Support Plans we will reduce the overall support plan fees by 20%.

Business Software Free Training Course Entitlements based on your level of cover above:
